This Policy of Insurance, Witnesseth, that in consideration of premium as agreed to be paid, this Company does insure **STELIOS KYRIAKIDES**

in the sum of **THREE THOUSAND-** Dollars,

on **PERSONAL EFFECTS (2 TRUNKS, 1 CASE & 1 VALISE)**

valued at sum insured, shipped on board of the s/s **"PETROS J. GOULANDRIS"**

at and from **NEW YORK**

to **PIRAEUS, GREECE**

lost or not lost. Loss, if any, payable to **ASSURED** or order, upon surrender of this Policy, without deduction (as against purchasers or pledgees of the goods) for unpaid premiums, and when so paid liability under this insurance is discharged.

Touching the adventures and perils which these Insurers are contented to bear and do upon themselves in this voyage, they are of the seas, fire, pirates, rovers, assailing waves, jettisons, criminal barratry of the master and mariners (unless the Assured on cargo owner or interested in vessel in whole or in part), and all other like perils, losses and misfortune, that have or shall come to the hurt, detriment or damage of the said goods and merchandise, or any part thereof.

EXCEPT AS OTHERWISE STATED HEREON IN WRITING, THIS INSURANCE IS WARRANTED FREE FROM PARTICULAR AVERAGE UNLESS THE VESSEL OR CRAFT BE STRANDED, SUNK, BURNT OR IN COLLISION.

SHIPMENTS ON DECK (WHICH MUST BE SPECIFICALLY STATED HEREON) ARE INSURED.—Warranted free of particular average unless caused by the vessel being stranded, sunk, burnt, on fire, or in collision, but including risk of jettison and/or washing overboard, of an entire shipping package.

This Insurance attaches from the time the goods leave the Warehouse and/or Store at the place named in the Policy for the commencement of the transit and continues during the ordinary course of transit, including customary transhipment if any, until the goods are discharged overboard from the overseas vessel at the final port. Thereafter the insurance continues whilst the goods are in transit and/or awaiting transit until delivered to final warehouse at the destination named in the Policy or until the expiry of 15 days (or 30 days if the destination to which the goods are insured is outside the limits of the port) whichever shall first occur. The time limits referred to above to be reckoned from midnight of the day on which the discharge overboard of the goods hereby insured from the overseas vessel is completed. Held covered at a premium to be arranged in the event of transshipment, if any, other than as above and/or in the event of delay in excess of the above time limits arising from circumstances beyond the control of the Assured.

Where this insurance by its terms covers while on docks, wharves or elsewhere on shore and/or during land transportation, it shall include the risks of collision, derailment or overturning of the conveyance, fire, cyclones, hurricanes, earthquakes, floods (meaning the rising of navigable waters) and/or collapse or subsidence of docks or wharves.

This insurance shall not be vitiated by any unintentional error in description of vessel, voyage or interest, or by deviation, over-carriage, change of voyage, transshipment or any other interruption of the ordinary course of transit from causes beyond the control of the Assured. It is agreed, however, that any such error, deviation or other occurrence mentioned above shall be reported to this Company as soon as known to the Assured, and additional premium paid if required.

NOTE.—IT IS NECESSARY FOR THE ASSURED TO GIVE PROMPT NOTICE TO UNDERWRITERS WHEN HE BECOMES AWARE OF AN EVENT FOR WHICH HE IS "HELD COVERED" UNDER THIS POLICY AND THE RIGHT TO SUCH COVER IS DEPENDENT ON COMPLIANCE WITH THIS OBLIGATION.

IN CASE OF LOSS OR DAMAGE PLEASE FOLLOW INSTRUCTIONS ON THE REVERSE SIDE OF THIS POLICY.

**ORIGINAL — DUPLICATE UNPAID**

AND, in case of any loss or misfortune, it shall be lawful and necessary to send for the Assured, his stevedores and assistants, to view, labor and test, for and about the cargo, and to take all such measures as may be necessary for the safekeeping and recovery of the said goods and merchandise, or any part thereof, and to do all such things as may be necessary for the preservation of the property insured, in case of disaster, be considered a waiver or an acceptance of an abandonment; and to the charges whereof these Insurers will contribute in proportion as the sum hereby insured is to the whole sum at risk.

In case the interest hereby insured is covered by other insurance (except as hereinafter provided) the loss shall be collected from the several policies in the order of the date of their attachment, insurance attaching on the same date to be deemed simultaneous and contribute pro rata; PROVIDED, NEVERTHELESS, that where any fire insurance, or any insurance by TOLLEY, or would be so available if this insurance did not exist, then this insurance shall be void to the extent that such other insurance is or would have been available; but in such cases these Assurers shall receive and retain the premium payable under this Policy and, in consideration thereof, shall guarantee the solvency of the companies and/or underwriters, who issued such other insurance, and the prompt collection of the loss thereunder to the same extent as this insurance, shall have become void under the terms of this clause; but not if such other insurance did not exist.

Where goods are shipped under a bill of lading containing the so-called "Both-to-Blame" Clause, or any clause in any bill of lading whereby the Assured may be legally bound to pay to the ship owners under such clause, in the event that such liability is asserted and the Assured agree to notify the Assurers who shall have the right, at their own cost and expense, to defend the Assured against such claim.

The Assured are not to be prejudiced by the presence of the negligence clause and/or latent defect clause in the Bills of Lading and/or Charter Party. The seaworthiness of the vessel as between the Assured and the Underwriters is hereby admitted and the wrongful act or misconduct of the shipowner or his servants causing a loss is not to defeat the recovery by an innocent assured if the loss in the absence of such wrongful act or misconduct as an immediate cause of the loss, has been caused by the negligence of the crew, pilot, or other persons on board, or by the negligence of the vessel, or by the negligence of the pilots, and to tow and assist vessels or craft in all situations, and to be towed.

General Average and Salvage Charges payable according to United States laws and usage and/or as per Foreign Statement and/or as per London-Antwerp Rules (as prescribed in whole or in part) if in accordance with the Contract of Affreightment.

In case of General Average and/or Salvage, the liability of these Assurers shall in no event exceed such proportion thereof as the amount hereby insured (after deduction of the amount paid by or due from these Assurers for particular average) bears to the contributory value of the insured property.

Warranted by the Assured free from damage or injury from dampness, rust, chafe, or decay, or from being spotted, discolored, musty or mouldy, unless such damage or injury is insured against and is not excluded by the F. P. A. warranty. Warranted free of claim for loss of market or for loss, damage or deterioration arising from delay, whether such delay is caused by a perils insured against or otherwise, unless the risk of delay is expressly assumed in writing hereon.

Grounding in Canals, Harbors or other Rivers not to be deemed a stranding, but the Assurers will be liable therefor, unless it be proved to have resulted therefrom and which would be recoverable if caused by stranding.

In case of loss or injury to any part of a machine, consisting wholly or in part of sale or use of several parts, the liability of the Insurers shall in no event exceed the insured value of the part lost or damaged.

In case of damage affecting labels, capsules or wrappers, these Assurers, if liable therefor, shall not be liable for more than an amount sufficient to pay the cost of new labels, capsules or wrappers, and the cost of reconditioning the goods, but in no event shall this Company be liable for more than the insured value of the damaged merchandise.

No recovery for a constructive total loss shall be made hereunder unless the property hereby insured is reasonably abandoned on account of its actual loss appearing to be unavoidable, or because it cannot be preserved from actual total loss without an expenditure which would exceed its value when the expense had been incurred.

Breachage of goods or merchandise or leakage of liquids (except when caused by stranding or collision with another vessel) is not insured, unless agreed in writing hereon.

It is agreed that upon the payment of any loss or damage, these Assurers are to be subrogated to all the rights of the Assured arising out of such loss or damage; and the Assured warrant and agree that no special agreement or waiver has been or will be made with any third party, which would prejudice the Assurers in their recovery, whether by such carrier or bailee shall be released from its or his common law or statutory liability.

Warranted that this insurance shall not inure, directly or indirectly, to the benefit of any carrier or bailee.

### IMPORTANT NOTICE

All Policies and/or Certificates issued, claims on which are made payable at destinations in the United Kingdom of Great Britain and Northern Ireland, British India and the colony of the Straits Settlements, are by law required to have a government stamp affixed within a specified number of days after receipt, in the place where the claim has been made payable, otherwise no payment can be made. In other countries similar laws may obtain. The attention of holders of Policies and/or Certificates is particularly drawn to this.

Loss of or damage to the interest hereby insured must be promptly reported to the agent of the Assurers named below, located at the port of discharge or disaster, and such agent must be represented on all surveys and must certify the correctness of all proofs of loss and bills of expense. If there be no such agent at or near the place where the loss is discovered or the expenses are incurred, then such report shall be made to the nearest representative of the Board of Underwriters of New York or Lloyds' Agent, and his certification obtained as above.

It is agreed that a claim agent's intervention is for the purpose, only, of ascertaining the nature, cause, and extent of the loss or damage and he is not to be subjected to legal proceedings.

### IMPORTANT NOTICE

In addition to the survey it is imperative that a claim in writing be made on the carrier, if possible, before accepting delivery. Making claim on the carrier will not jeopardize the insurance claim.

All claims hereunder shall be submitted for approval to, and be adjusted by, the Company or its nearest Settling Agents, and upon their authentication, will be paid by the Company or its Bankers at the current rates of exchange.

The adjustment will be in accordance with the usages at Lloyd's, and subject to the conditions of the policy.
