I Work

Decide what to give up:

Law Commission,  
Scholarship Board,  
Adviser in the Intercommunal  
Talks,  
Red Cross.

The Law Commission  
can be given up.  
Find out what gratuity

or in a year's time  
or in two years' time.  
Possible successor:

The Scholarship Board  
can be given up.

Possibly retain some  
connection: eg. President of  
the Board, participating in  
policy decisions and, if  
thought fit, in Selection  
Boards.

Chairman of the Board,  
who would be responsible

If Home

Move to Limassol

Also keep a flat in Nicosia.

Choose from mother's house  
& from Palaeologoussa Street  
what should be moved to

flat in Nicosia.

## III Property

What/Whether to sell.

Consider selling the 2-roomed flat (N315) in Arctura.

What to transfer to A & D.

Give the money to Alexia or buy a flat in Nicosia

Whether to establish a company.

(which can be given to Alexia) (but see below re. company)  
Transfer half of Flat 71 to Dimitri.

Where to keep the Files/Records

Files/Records can either stay in Nicosia at the I/hunter's office or be transferred to Palsologos House.

Possibly create a company & transfer to it: (Advise of Accountant & George to be sought)  
The three flats ~~the~~ (11, 12 & 15 Arctura) & the shop, & the building site ~~at~~ next to parents' house, & my share of parents' house. (Not Flamingo 32, or Arctura 71) - or of course the Nicosia 1/0 house & building sites). Arrangements to be made for S. & D. to get income, either as fee or otherwise, for life.

Transfer 49% of shares to Alexia. The other 51% being divided between Dimitri & myself. Or divide shares equally: D., A. & myself. (The latter seems preferable)  
Arrangements for management of company to be made.

What disposition to make:

Property

Files and Records

If Company is formed,  
no need to make any  
disposition by will.  
If I die,  
Dimitri will automatically  
have all the Joint Apts.,  
 $\frac{1}{2}$  Half of Flat 32 Flamingo, &  
half of Flat 71 Arcthusa  
~~Alexia will have~~  
~~shares~~ +  $\frac{1}{6}$  of my half, i.e.  $\frac{7}{12}$  of  
32 Flamingo &  
71 Arcthusa  
~~Alexia will~~

He will also have his  
shares in the Company +  $\frac{1}{6}$  of my  
shares.

If I die, I would have the same as D.

Alexia will have  $\frac{5}{12}$  of  
Flat 32 Flamingo & of Flat 71 Arcthusa,  
her shares in the Co.  
plus  $\frac{1}{6}$  plus  $\frac{5}{6}$  of my shares

Consider only possibility of  
making a disposition of  $\frac{1}{2}$  share in Flat 71  
from me to D. & vice-versa.

Files/Records: Consider creating  
a Trust

(Look at Trust created by

house).
